Thank you so much for signing nomination papers for **Enrique Murguia** to help get him on the ballot for **Wisconsin State Assembly, District 8**. Here are some helpful instructions when filling out the nomination papers:

Before you start: In order to fill out the form to get Enrique Murguia on the ballot, you must be a resident of Assembly District 8 – [check the map](#)

- You do not need to be registered to vote to sign the petition but rather eligible to register and vote. That generally means 18 years or older, a U.S. Citizen, you have lived in the district for at least 10 days, and you have not lost the right to vote due to a criminal felony conviction for which the person is currently on probation, parole or extended supervision.
- A person may sign only one nomination paper for a candidate for a Congressional District in an election period. If you have signed another person's nomination paper for the 8th Assembly District then you cannot sign the nomination papers.
- ALL signatures must be accompanied by a legibly printed name, the signer's full address, and date of signing (please don't skip any boxes). Also please indicate whether or not your municipality is a city or a village. Post office and rural route numbers are not acceptable. The signer must indicate his/her residence, including street numbers.
- Near the bottom of the form underneath the heading "Certification of Circulator", please re-print both your name and your full address (Number, Street, Municipality, and Zip Code). Only one person can serve as circulator, and they should only sign after everyone in your household who is eligible signs the form above.
- If your nomination papers ONLY have your name or ONE name, signature and address, that's not a problem. You should sign and date the "Certification of Circulator" at the bottom and mail this back to the campaign. **Do not wait to gather signatures if you cannot do it safely.**

**Forms MUST BE returned by May 20th at the latest.** They cannot be emailed, texted, scanned, or faxed. To return the completed form:
